ORDINANCE NO. 376, S-2007

AN ORDINANCE AMENDING ORDINANCE NO. 315, S-2005 AND ORDINANCE NO. 358, S-2005 TO CORRECT THE TYPOGRAPHICAL ERRORS THEREIN OF STREET NAMES C. V. VICTORINO AND D. C. FERNANDEZ, BOTH IN BARANGAY PLEASANT HILLS, CITY OF MANDALUYONG, AS V. VICTORIO AND C. FERNANDO, RESPECTIVELY, AND FOR OTHER PURPOSES

BE IT ORDAINED by the Sangguniang Panlungsod of Mandaluyong in session assembled, that:

SECTION 1. Ordinance No. 315, S-2005 entitled: *"An Ordinance Adopting the Official Political Map of the City of Mandaluyong,"* Appendix 1 and Ordinance No. 358, S-2005 entitled: *"Traffic Management Code of the City of Mandaluyong, Metro Manila,"* Appendix XI, are hereby both so amended only to correct the typographical errors therein of street names C. V. VICTORINO and D. C. FERNANDEZ, both in Barangay Pleasant Hills, as V. VICTORIO and C. FERNANDO, respectively.

SECTION 2. The City Planning and Development Office shall accordingly make the necessary corrections of the typographical errors of the street names herein mentioned on the Official Political Map of the City of Mandaluyong adopted under Ordinance No. 315, S-2005.

SECTION 3. This Ordinance shall take effect upon its approval.


