**ORDINANCE NO. 528, S-2013**

AN ORDINANCE DESIGNATING LEE STREET, BARANGAY ADDITION HILLS,  
AS A NO PARKING/TOW AWAY ZONE AND TO INCLUDE THE SAME  
IN THE LIST OF NO PARKING/TOW AWAY ZONES UNDER  
APPENDIX III OF ORDINANCE NO. 358, S-2005  
OTHERWISE KNOWN AS THE TRAFFIC  
MANAGEMENT CODE OF THE CITY OF MANDALUYONG

WHEREAS, the areas surrounding the Wack-Wack Golf and Country Club is fast evolving into a highly commercial-high-end Residential Center manifested by the sudden influx of high rise condominiums, apartelles and mixed-use buildings (i.e.: Lee Garden Tower and the Wack Wack Heights Condominium) that a sudden increase in traffic volume is expected;

WHEREAS, Lee Street, being located in the same area is now experiencing moderate to heavy traffic congestion that there is now a need to classify it as a No Parking/Tow Away Zone to prevent traffic congestion in the area;

WHEREAS, there is an existing list of roads/streets classified as No Parking/Tow Away Zone under Appendix III of Ordinance No. 358, S-2005 otherwise known as The Traffic Management Code of the City of Mandaluyong, wherein this Ordinance seeks to designate Lee Street as a No Parking/Tow Away Zone and to include the same on the list under Appendix III of Ordinance No. 358, S-2005.


NOW, THEREFORE, be it ORDAINED by the Sangguniang Panlungsod of Mandaluyong in session assembled:

SECTION 1. Lee Street shall, henceforth, be classified as a No Parking/Tow Away Zone and shall be added to the existing list of No Parking/Tow Away Zones as indicated under Appendix III of Ordinance No. 358, S-2005.

SECTION 2. This Ordinance shall take effect upon approval.
