ORDINANCE NO. 549, S-2014

**AN ORDINANCE GRANTING FRANCHISE AND/OR AUTHORITY
TO AAMEE ELECTRONIC GAME STATION TO OPERATE
AN ELECTRONIC BINGO (E-BINGO) AT
SHAW CENTER MALL, CITY OF MANDALUYONG**

WHEREAS, in his letter dated July 08, 2014, MR. EDUARDO RICARDO A. OCHOA, sole proprietor, AAMEE Electronic Game Station, manifested his Company's intention to put up an Electronic Bingo (E-Bingo) Station at Shaw Center Mall, Barangay Addition Hills, City of Mandaluyong, and accordingly requested for authority to operate the aforesaid endeavor;

WHEREAS, AAMEE Electronic Game Station, a sole proprietorship duly registered and existing under and by virtue of the laws of the Republic of the Philippines as evidenced by the Department of Trade & Industry issued Certificate of Business Registration with an authorized capital stock of Two Million Pesos (P2,000,000.00);

WHEREAS, the primary purpose of AAMEE Electronic Game Station is to conduct, maintain, operate, promote and engage in the business of entertainment and recreation including the operation of Electronic Bingo (E-Bingo) and similar games.

NOW, THEREFORE, finding that AAMEE Electronic Game Station has all the qualifications and finding further, from the pertinent documents appended to the letter, that the AAMEE Electronic Game Station is legally qualified and financially capable to operate the proposed Electronic Bingo (E-Bingo) and considering its commitment to secure all the permits required by the appropriate agencies of the National Government prior to its operation, the Sangguniang Panlungsod of the City of Mandaluyong, in session assembled hereby ORDAINS, that:

- SECTION 1. AAMEE Electronic Game Station is hereby granted a franchise and/or authority to operate an Electronic Bingo (E-Bingo) at Shaw Center Mall, Barangay Addition Hills, Mandaluyong City subject, however, to prior compliance of the requirements of the Philippine Gaming Corporation (PAGCOR) as this Ordinance is intended for venue purposes only;
- SECTION 2. The applicant shall comply with all the necessary requisites mandated by City Ordinance No. 408, S-2008, such as but not limited to the securing of a Mayor's Permit for the operation of the Electronic Bingo (E-Bingo);
- SECTION 3. The employees of said applicant, except those holding managerial and supervisory positions, shall secure a Mayor's Permit and other clearances prior to their employment thereof;
- SECTION 4. The franchise and/or authority to operate an Electronic Bingo (E-Bingo) shall be strictly limited to the following:
- a. The holding of electronic bingo in accordance with the Rules and Regulations promulgated and implemented by the Philippine Gaming Corporation (PAGCOR) and;

- b. The provision of City Ordinance No. 408, S-2008 shall, likewise, be strictly enforced and/or observed.

SECTION 5. The grant of this franchise and/or authority to operate Electronic Bingo (E-Bingo) shall be for a period of five (5) years only from date of approval and shall be subject to Ordinance No. 253, S-2002, known as the Franchise Tax Ordinance of Mandaluyong, and this approval is without prejudice to taxation/levies that might be imposed by the Sangguniang Panlungsod after the grant of this franchise or authority.


SECTION 6. This Ordinance shall take effect upon its approval.

ENACTED on this 28th day of July, 2014 in the City of Mandaluyong.


