ORDINANCE NO. 558, S-2014

**ORDINANCE REGULATING THE ESTABLISHMENT
AND OPERATION OF DENTAL PROSTHETIC
LABORATORIES IN THE CITY OF
MANDALUYONG AND FOR OTHER PURPOSES**

BE IT ORDAINED by the Sangguniang Panlungsod of Mandaluyong, in session assembled:

SECTION 1. No person, whether juridical or natural, shall operate and maintain dental prosthetic of dentistry or operate and maintain dental prosthetic laboratory unless a Mayor's Permit is first issued.

SECTION 2. No Mayor's Permit shall be issued to any person to operate and maintain dental prosthetic laboratory unless the applicant is previously licensed by the Department of Health, through the Bureau of Licensing and Regulation.

SECTION 3. The Mayor's Permit required under this Ordinance shall be issued by the Mayor upon recommendation of the City Health Officer.

SECTION 4. FEES. The Mayor's Permit required under this Ordinance shall be issued only upon payment of the following fees:

Registration Fee	P 110.00
License Fee	P 660.00

SECTION 5. VALIDITY OF MAYOR'S PERMIT. The Mayor's Permit issued under this Ordinance shall be valid only up to December 31 of the year it was issued and must be renewed every year thereafter not later than January 20 of the ensuing year.

SECTION 6. Any person, whether juridical or natural, found operating and maintaining a dental prosthetic laboratory within the City of Mandaluyong, without a Mayor's Permit shall upon conviction, be punished with imprisonment of not less than one (1) month or more than three (3) months or a fine of not less than One Thousand Five Hundred Pesos (P1,500.00) but not more than Two Thousand Five Hundred Pesos (P2,500.00) or both at the discretion of the court.


If the offender is a juridical person, the penalty herein provided shall be imposed upon the President and/or General Manager, in case of corporation and upon the Managing Partner, in case of partnership.

SECTION 7. REPEALING CLAUSE. Ordinance No. 141, S-1994 and any Ordinance not consistent with the provisions of this Ordinance is hereby repealed.

SECTION 8. EFFECTIVITY. This Ordinance shall take effect immediately upon approval.
