ORDINANCE NO. 681, S-2017

ORDINANCE AMENDING ORDINANCE NO. 662, S-2017
"AN ORDINANCE GIVING AWARDS AND
INCENTIVES TO MANDALEÑO CENTENARIANS"

WHEREAS, as tribute to the invaluable contribution of our elderlies to the City, Honorable Mayor CARMELITA A. ABALOS announced during the Elderly Filipino Week Celebration last October 2, 2017 in our Monday Program that she will increase the centenarian incentive in the amount of ONE HUNDRED THOUSAND PESOS (P100,000.00) instead of Fifty Thousand Pesos (P50,000.00) to be given to Mandaleño Centenarian in addition to other benefits and privileges granted under existing laws, ordinances, rules and regulations as she wants them to experience and enjoy the love, care and assistance of the City Government of Mandaluyong in the remaining days of their lives.

BE IT ORDAINED by the Sangguniang Panlungsod of Mandaluyong, in Regular Session duly assembled that:

SECTION 1. Section 3, (c) of Ordinance No. 662, S-2017 is hereby amended to read as follows:

SECTION 3. AWARDS AND INCENTIVES. In addition to other benefits and privileges granted under existing laws, ordinances, rules and regulations, the following awards and incentives shall be given to the Mandaleño Centenarian during the annual commemoration by the City of the National Respect for Centenarians Day.


c. Centenarian Incentive in the amount of One Hundred Thousand Pesos (P100,000.00) cash.

SECTION 2. REPEALING CLAUSE. All local ordinances, rules and regulation or portion thereof that are inconsistent with the provision of this Ordinance are hereby repealed or modified accordingly.

SECTION 3. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval.
