ORDINANCE NO. 827, S-2021

**AN ORDINANCE TEMPORARILY
SUSPENDING THE CURFEW HOURS
PROVIDED UNDER SECTION 2 OF
ORDINANCE NO. 804, S-2020 IN THE
CITY OF MANDALUYONG**

WHEREAS, on October 19, 2020, the Sangguniang Panlungsod of Mandaluyong enacted Ordinance No. 804, S-2020 entitled "THE NEW CURFEW ORDINANCE OF MANDALUYONG CITY" which imposed curfew hours of 12am-4am except in case an Enhanced Community Quarantine or a Modified Enhanced Community Quarantine has been declared affecting the City of Mandaluyong, in which case, the curfew hours shall be 8pm-5am;

WHEREAS, the Metro Manila Council passed Resolution No. 21-03, Series of 2021 which set a Unified Curfew Hours of 10pm-5am for a period of two (2) weeks or from March 15, 2021 to March 31, 2021;

WHEREAS, upon recommendation of the Inter-Agency Task Force for the Management of Emerging Infectious Disease (IATF-EID), the National Capital Region (NCR) plus bubble was placed under Enhanced Community Quarantine (ECQ) from March 22-April 4, 2021 wherein the stricter curfew hours of 6pm-5am was implemented;

WHEREAS, the said ECQ measure was extended for another one week or from April 5 to April 11, 2021 which, likewise, extended the 6pm-5am curfew hours;

WHEREAS, upon the subsequent recommendation of the IATF-EID, the NCR plus bubble was transitioned to MECQ status from April 12, 2021 to April 30, 2021;

WHEREAS, pursuant to the declaration of MECQ on the above-mentioned dates, the Metro Manila Council agreed to set the Standardized and Unified Curfew Hours to 8pm-5am;

WHEREAS, on April 27, 2021, the Metro Manila Council issued Resolution No. 21-09 which set the new Standardized and Unified Curfew Hours in the National Capital Region from 10pm-4am starting on May 1, 2021;

WHEREAS, in order for the City to properly and effectively adopt and implement the curfew hours set by the National Government and the Metro Manila Council in various circumstances, the Office of the Local Chief Executive recommends, as it deems prudent, to temporarily suspend the effectivity of the prevailing curfew hours under the pertinent Ordinance in the City to prevent confusion and conflict in the implementation of overlapping curfew hours therein;

WHEREAS, the Sangguniang Panlungsod ng Mandaluyong agrees with the Office of the Local Chief Executive that the temporary suspension of the prevailing curfew hours would work for the greater benefit of the public as it will provide better flexibility in the execution, in the local level, of national guidelines in the midst of the COVID-19 pandemic as well as eliminate confusion and conflict between national and local protocols.

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod of the City of Mandaluyong, in session assembled:

Section 1. The effectivity of the curfew hours provided in Section 2 of Ordinance No. 804, S-2020 entitled "THE NEW CURFEW ORDINANCE OF MANDALUYONG CITY" is hereby temporarily suspended until further notice.

As such, the curfew hours of 8pm-5am, if the City is under Enhanced Community Quarantine or Modified Enhanced Community Quarantine, is hereby temporarily suspended.

Likewise, the curfew hours of 12am-4am, if the City is not otherwise under Enhanced Community Quarantine or Modified Enhanced Community Quarantine, is also temporarily suspended.

All other provisions of Ordinance No. 804, Series of 2020 shall remain in full force and effect.

Section 2. The curfew hours set by the Metro Manila Council from 10PM to 4AM is hereby adopted and imposed in Mandaluyong City starting on May 1, 2021, onwards.

Any issuance by the Metro Manila Council or the Metro Manila Development Authority with regard to the imposition of new curfew hours is likewise adopted, subject to the issuance of a proper Executive Order by the Local Chief Executive.

Section 3. All Ordinances and Resolutions or any part thereof which are inconsistent with the foregoing provision are hereby repealed or modified accordingly.


Section 4. If any provision of this Ordinance is determined to be invalid, illegal or unenforceable, its remaining provisions shall remain in full force as though this Ordinance did not originally include such invalid, illegal or unenforceable provision.


Section 5. This Ordinance shall take effect immediately upon approval, and shall remain in full force and effect until and unless repealed or otherwise suspended by a subsequent Ordinance on the matter.


Section 6. Let copy of this Ordinance be furnished the Office of the City Mayor, Mandaluyong City Police Station and those PNP personnel stationed in Mandaluyong City, Barangay Officials, City Ordinance and Enforcement Division (COED), Public Order and Safety Division, and other offices concerned, for their information, guidance, and reference.
