ORDINANCE NO. 453, S-2010

ORDINANCE AMENDING ORDINANCE NO. 352, S-2005 OTHERWISE KNOWN
AS "AN ORDINANCE PRESCRIBING CERTAIN REQUIREMENTS IN THE
GRANT OR RENEWAL OF MAYOR'S PERMIT TO OPERATE
AN AUTO REPAIR OR VULCANIZING SHOP"

BE IT ENACTED by the Sangguniang Panlungsod of the City of Mandaluyong, in session assembled:

SECTION 1. DEFINITION OF TERMS. For purposes of this Ordinance, the following shall mean:

AUTO REPAIR OR VULCANIZING SHOP – a place where all types of motor vehicles are being repaired or where flat tires are fixed for a fee.

GARAGE – is a portion of the area where all types of auto repair or work are done on a motor vehicle.

OWNER – is any person, whether natural or individual, in whose favor a Mayor's Permit to operate an auto repair or vulcanizing shop is applied for and/or granted.

- SECTION 2. No auto repair or vulcanizing shop shall be operated without a Mayor's Permit first obtained.
- SECTION 3. Any person found operating an auto repair or vulcanizing shop without any Mayor's Permit shall, upon conviction, be punished by a fine of not less than Five Hundred (P500.00) Pesos, but not more than One Thousand (P1,000.00) or imprisonment of not more than six (6) months, or both, at the discretion of the court.
- SECTION 4. If the offender is a corporation or a partnership, the penalties prescribed above shall be imposed upon the President and/or General Manager or Managing Partner and/or General Manager, respectively.
- SECTION 5. NO CONTEST PROVISION. Any person, individual or entity apprehended or cited for violation of this Ordinance who does not wish to contest the violation and is willing to pay voluntarily the imposable minimum fine prior to the filing of formal charges shall be allowed to pay said fine with the City Treasurer.

For this purpose, the City Treasurer is hereby directed to provide the necessary manpower to accept the payment of fines twenty-four (24) hours a day so as not to jeopardize the right of the offender. ATTESTED:

SECTION 6. This Amended Ordinance shall take effect upon approval.
