ORDINANCE NO. 825, S-2021

AN ORDINANCE AMENDING APPENDIX II OF
ORDINANCE NO. 743, S-2019 OR THE
OMNIBUS TRAFFIC MANAGEMENT CODE OF
THE CITY OF MANDALUYONG

WHEREAS, Local Government Units are mandated to maintain all local roads within their jurisdiction as a basic service and facility, pursuant to Section 17 (b) of Republic Act 7160 or the Local Government Code of 1991;

WHEREAS, the Department of the Interior and Local Government (DILG) issued Memorandum Circular No. 2020-145 regarding the Continuation of Road Clearing in accordance with Section 4 of Republic Act 11494 or the Bayanihan to Recover as One Act;

WHEREAS, Mr. Alex I. Santos, Head of the City Traffic and Parking Management Department, wrote to the Sangguniang Panlungsod last February 24, 2021 appealing to the City Council to harmonize the Anti-Street Obstruction and the Omnibus Traffic Management Code of the City of Mandaluyong;

WHEREAS, the Committee on Peace and Order, Public Safety and Fire Protection conducted a public hearing on March 31, 2021 regarding the letter from Mr. Santos and the numerous complaints in the implementation of the Anti-Street Obstruction Ordinance which is in direct conflict with the provisions (Appendix II-Addendum to Zone per Barangay) of Ordinance No. 743, S-2019 or the Omnibus Traffic Management Code of the City of Mandaluyong;

WHEREAS, during the hearing, Barangay Chairman BERNARDO M. EVANGELISTA of Barangay Mauway, recommended that "Antipolo Left side (from Bulusan to Montalban)" under One-Side Parking Streets be amended and declared as No Parking Areas.

BE IT ORDAINED by the Sangguniang Panlungsod of the City of Mandaluyong, in session assembled:

SECTION 1. Appendix II-Addendum to Zone per Barangay of Ordinance No. 743, S-2019 or the Omnibus Traffic Management Code of the City of Mandaluyong is hereby amended as follows:

SECTION 2. This Ordinance shall take effect after publication in a newspaper of general circulation in Metro Manila.
