ORDINANCE NO. 795, S-2020

AN ORDINANCE AMENDING SECTION 5 OF  
ORDINANCE NO. 767, S-2020 OTHERWISE  
KNOWN AS "MANDATORY WEARING OF FACE  
MASKS ORDINANCE", AND IMPOSING  
PENALTIES FOR VIOLATIONS THEREOF

WHEREAS, the Sangguniang Panlungsod ng Mandaluyong has enacted Ordinance No. 767, S-2020, on April 8, 2020, which mandated that all persons in public places within the territorial jurisdiction of Mandaluyong City without a face mask or face covering shall be liable under said Ordinance;

WHEREAS, during the protracted period of Community Quarantine, the Local Government of Mandaluyong takes cognizance of the level of unemployment among its constituents resulting to economic difficulty;

WHEREAS, the Local Government of Mandaluyong sympathizes with its constituents in these trying times of economic hardship, and therefore finds it proper to reduce the penalty for violations of the Mandatory Wearing of Face Masks.

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod in session duly assembled that:

SECTION 1. Amendment to Section 5 of Ordinance No. 767, S-2020. - Section 5 of Ordinance No. 767, S-2020 is hereby amended to read as follows:

"SECTION 5. PENALTIES. - Any person who violates this Ordinance shall suffer the penalty of:



| a.) First Offense:       | Fine of One Hundred Pesos (P100.00);   |
| b.) Second Offense:      | Fine of Two Hundred Pesos (P200.00);   |
| c.) Third Offense:       | Fine of Three Hundred Pesos (P300.00);   |
| d.) Subsequent offenses: | Fine of Five Hundred Pesos (P500.00),<br>or imprisonment of one (1) week, or both,<br>at the discretion of the court." |

SECTION 2. Repealing Clause. - All ordinances, resolutions, rules and regulations or parts thereof, which are previously issued and inconsistent herewith, are deemed amended or modified accordingly.


SECTION 3. Effectivity. - This Ordinance shall take effect immediately upon approval.
