RESOLUTION NO. 2518, S-2018

RESOLUTION AUTHORIZING THE HONORABLE MAYOR CARMELITA A. ABALOS TO SIGN AND ENTER INTO AN AGREEMENT WITH NEPHROLOGY BASIC DIALYSIS CENTER INC. FOR ESTABLISHMENT OF HEMODIALYSIS FACILITIES IN THE CITY OF MANDALUYONG

WHEREAS, studies show that an estimate 120 Filipinos per million population (PMP) develop kidney failure each year, meaning that about 10,000 Filipinos need to replace their kidney function each year;

WHEREAS, the study, likewise, shows that only 73% of the total patients received dialysis treatment because they were able to get to a hospital providing dialysis or could afford the therapy;

WHEREAS, further study shows that the acceptance rate of treatment for kidney failure in the Philippines is only 86 per million population (PMP), compared to 100 PMP in South Korea, and 300 PMP in the United States, thus, a quarter of Filipino patients probably just died without receiving any treatment for the past years;

WHEREAS, in the City of Mandaluyong, a significant number of patients suffering from renal failure has been noted and recorded;

WHEREAS, due to the exorbitant cost of the hemodialysis, patients with renal failure cannot sustain this treatment for more than a year, or sadly, cannot even afford to have few sessions of it;


WHEREAS, as per various hospital records, the adequate dialysis cost is from Php25,000.00 to Php46,000.00 per patient per month or Php300,000.00 to Php552,000.00 annually;

WHEREAS, establishing a Hemodialysis Center in the City of Mandaluyong that would cater to the City residents, including and most importantly, the indigent people of the City, would be a gigantic step towards winning a battle in the current problem of the City regarding combating the illness of renal failure that have afflicted a significant number of people of the City, most especially, in the indigent sector.


NOW, THEREFORE, in a motion duly seconded, the Sangguniang Panlungsod, of the City of Mandaluyong, in a session duly called, RESOLVED, as it hereby RESOLVES, to authorize the Honorable Mayor CARMELITA A. ABALOS, to enter into an agreement with Nephrology Basic Dialysis Center Inc. for the establishment of a Hemodialysis facilities in the City of Mandaluyong.

ADOPTED on this 12th day of February, 2018 in the City of Mandaluyong.
