RESOLUTION NO. 2522, S-2018

RESOLUTION AUTHORIZING HONORABLE CITY MAYOR CARMELITA A. ABALOS TO EXTEND IMMEDIATE FINANCIAL ASSISTANCE TO THE PROVINCE OF ALBAY LOCAL GOVERNMENT UNITS (LGUs) IN THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) TO GIVE AID AND RELIEF TO THE DISPLACED FAMILIES AND COMMUNITIES OF ALBAY LGUs

WHEREAS, pursuant to the MMDA Resolution No. 18-02, Series of 2018, approved on February 7, 2018, in the spirit of *Bayanihan* and mutual support, the Metro Manila Council has committed its immediate assistance to the adversely affected Local Government Units of Tabaco, Ligao, Guinobatan, Camalig, Daraga, Legazpi, Sto. Domingo, Malilipot, and Bacacay in the Province of Albay ("Albay LGUs");

WHEREAS, Mayon Volcano has been seen spurting red-hot lava and ash, and continued to erupt over the past weeks. Its eruption has unleashed havoc in the country after more than 60,000 residents were forced to flee their homes and escape the volcano's danger zone;

WHEREAS, because of the hazardous eruption and damage caused, the Sangguniang Panlalawigan of Albay declared its area under State of Calamity through Resolution No. 670-2018;


WHEREAS, in furtherance of humanitarian efforts, rapport and camaraderie among LGUs, the City Government of Mandaluyong deems it necessary to extend financial assistance to the Albay LGUs and the people of Albay amounting to One Million Pesos (P1,000,000.00) in response to those displaced by the continuing eruption of Mayon Volcano chargeable against the Local Disaster Risk Reduction and Management Fund of the City subject to applicable accounting and auditing laws, rules and regulations.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize Honorable City Mayor CARMELITA A. ABALOS to extend immediate financial assistance to the Albay Local Government Units (LGUs) in the amount of One Million Pesos (P1,000,000.00) to give aid and relief to the displaced families and communities of Albay LGUs.

RESOLVED FURTHER, that a copy of this Resolution be furnished to the Metro Manila Council.

ADOPTED on this 21st day of February, 2018 in the City of Mandaluyong.
