RESOLUTION NO. 2529, S-2018

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR CARMELITA A. ABALOS TO ENTER INTO AND SIGN THE **MEMORANDUM OF AGREEMENT** BETWEEN THE CITY GOVERNMENT OF MANDALUYONG AND CONCERNED EDUCATIONAL INSTITUTION AS REGARDS THE LATTER'S WORK IMMERSION PROGRAM FOR THE SENIOR HIGH SCHOOL STUDENTS

WHEREAS, one of the goals of the K to 12 Basic Educational Program is to develop in learners the **competencies, work ethics and values** relevant to pursuing further education **and/or** joining the world of work. To achieve greater **congruence** between basic education and the nation's development targets, Work Immersion, a required subject, **has** been **incorporated** into the curriculum. This subject will **provide** learners with opportunities:

1. To **become** familiar with the work place;
2. For employment simulation; **and**
3. To apply their **competencies** in **areas** of **specialization/applied** subjects in authentic **work environments**.

To **achieve** the above objectives, Work Immersion is, thus, a requirement for graduation from **secondary** education. Learners are immersed in actual **work environments** such **as** **workshops, offices and laboratories** in which their prior training is relevant;

WHEREAS, a number of educational institutions **desires** to reach out with the City Government of **Mandaluyong** for a possible partnership in deploying their Senior High School students for a work immersion that **would** enable them to **enhance** their technical knowledge/skills and to prepare them to meet the needs and **challenges** of employment by providing a relevant **learning experience** by having **an exposure** to the actual workplace experience;

WHEREAS, the City is willing to **support** the program of the **educational institution** and give their students subject-related work assignments and expose them to actual learning experience;

WHEREAS, a **Memorandum of Agreement (MOA)** between the **concerned educational institution** and the City Government of **Mandaluyong** is necessary to set forth the terms **and conditions** of the work immersion, **as well as** their complementary duties and **responsibilities** in this timely endeavor and a draft of the **same was** already prepared by the City Legal Department;

WHEREAS, the proposed MOA sets the duties and **obligations** needed to be followed and abide by both parties therein **and the same** appears to be in **accordance** with the law and is **reasonably and** properly crafted;

WHEREAS, there is a need to authorize the City Mayor, Honorable CARMELITA A. ABALOS, via a **Resolution** to enter into **and sign** the **MOA** between the concerned **educational institution** **and** the City Government of Mandaluyong.
