RESOLUTION NO. 2555, S-2018

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR CARMELITA A. ABALOS TO ACCEPT AND EXECUTE THE DEED OF DONATION OF 170 UNITS OF E-TRIKE WITH THE DEPARTMENT OF ENERGY (DOE)

WHEREAS, the Constitution mandates that the State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature;

WHEREAS, consistent with this constitutional mandate, the City of Mandaluyong desires to keep sustainable economic development whereby progress meets cleaner and healthier environment for the benefit of all Mandaleños;

WHEREAS, the City of Mandaluyong has adopted a policy for the mainstreaming of climate change adaptation as well as local resiliency on climate-change disasters in all its ordinances, rules and regulations;

WHEREAS, toward this end, the City of Mandaluyong has adopted and approved the Comprehensive Land Use Plan for 2017 to 2032 wherein one of the major thrusts is to make a "Walkable City", where there is improved air quality, energy efficiency and reduced noise pollution from all modes of transportation plying the busy roads and streets of the City;

WHEREAS, the use of E-Trikes has been introduced to the City of Mandaluyong with the assistance of the Asian Development Bank (ADB) in 2011. Unfortunately, full appreciation by the stakeholders was halted by concerns on its high price, short battery life and longer charging time;

WHEREAS, the Philippine Government, through the DOE, recently launched the Market Transformation through Introduction of Energy Efficient Electric Vehicles Project or the E-Trike Project with the view of achieving a cleaner environment and contribute to national energy security;


WHEREAS, cooperating in this project, the City of Mandaluyong shall be the recipient of one hundred seventy (170) units of E-Trikes from the DOE to be distributed to different Tricycle Operators and Drivers Associations (TODA) Cooperative, Barangays, Health Centers and E-Trike Service Fleet for City Government offices within the jurisdiction of the City.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, to authorize the Honorable Mayor CARMELITA A. ABALOS to accept the donation of 170 units of E-Trikes from the Department of Energy (DOE), and execute the Deed of Donation for the purpose.

RESOLVED FURTHER, that copies of this Resolution be furnished to the Honorable Mayor CARMELITA A. ABALOS at the Office of the Mayor, Department of Energy (DOE), City Treasury Department, City Planning and Development Department and City Accounting Department for their immediate information.
