A RESOLUTION AUTHORIZING THE HONORABLE MAYOR CARMELITA A. ABALOS TO ENTER INTO AND SIGN THE GENERAL MEMORANDUM OF AGREEMENT AND SUBSEQUENT SPECIFIC IMPLEMENTATION AGREEMENTS FOR AND IN BEHALF OF THE CITY GOVERNMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT-NATIONAL CAPITAL REGION (DSWD-NCR) TO ESTABLISH A PARTNERSHIP WHICH WILL DEVELOP AND IMPLEMENT A SOCIAL PROTECTION PROGRAM IN THE CITY OF MANDALUYONG

WHEREAS, the Department of Social Welfare and Development (DSWD) envisions a society where the poor, vulnerable and disadvantaged individuals, families, and communities are empowered for an improved quality of life, and takes protection of the poor and marginalized members of society as its main mission otherwise referred as "Social Protection";

WHEREAS, in pursuit of the said vision and to operationalize its Social Protection mission, the DSWD adopts a "Whole of DSWD" approach in ensuring convergence in implementation of its various strategies, programs, projects and activities, otherwise known as "PPAs" to address the needs of the poor;

WHEREAS, under the Local Government Code, Local Government Units are mandated to address the needs of its constituents and empower the people through direct participation in the affairs of the government, by allowing them the widest possible space to decide on, initiate, implement, and innovate on development activities that address their identified needs;

WHEREAS, the City of Mandaluyong recognizes its role in ensuring inclusive development and commits to address the needs of the poor within its jurisdiction;

WHEREAS, the DSWD and the City of Mandaluyong are willing and able to partner with each other to deliver a package of services to address poverty, empower citizens, and promote inclusive growth, composed of some PPAs and agree to commit with each other to a partnership through a Memorandum of Agreement;

WHEREAS, the DSWD and the City of Mandaluyong agree to engage in a partnership with the objective of reducing poverty in the City through a coordinated and complementary implementation of social protection programs, projects, and activities supported by resources to be provided by all parties;

WHEREAS, there was already a Resolution authorizing the City Mayor, CARMELITA A. ABALOS, to enter into and sign a General Memorandum of Agreement and subsequent Specific Implementation Agreement for and in behalf of the City Government with DSWD-NCR, adopted last June 5, 2017;


WHEREAS, there is a need to enact another resolution authorizing the City Mayor, CARMELITA A. ABALOS, to enter into and sign a General Memorandum of Agreement and subsequent Specific Implementation Agreements for and in behalf of the City Government with DSWD-NCR, which Agreement stipulates the effectivity period.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize Honorable Mayor CARMELITA A. ABALOS to enter into and sign the General Memorandum of Agreement and subsequent Specific Implementation Agreements for and in behalf of the City Government with the DSWD-NCR to establish a partnership which will develop and implement a social protection program in the City of Mandaluyong.

FURTHER, RESOLVED, as it hereby RESOLVES, that copies of this Resolution be furnished to the Office of the City Mayor, City Social Welfare and Development Department and Day Care Service Program Division for their information and appropriate action.


