**RESOLUTION NO. 2589, S-2018**

RESOLUTION AUTHORIZING THE HONORABLE MAYOR CARMELITA A. ABALOS TO SIGN THE PROJECT CONTRACT WITH ALEXA TRADING AND CONSTRUCTION FOR THE CONSTRUCTION OF SEWERAGE TREATMENT PLANT (STP) ROOM WITH SEPTIC VAULT LOCATED AT MANDALUYONG CITY DIALYSIS CENTER (MCDC), F. MARTINEZ STREET (C-3 ROAD), BARANGAY ADDITION HILLS, CITY OF MANDALUYONG

WHEREAS, the Bids and Awards Committee of the City of Mandaluyong caused the issuance of an Invitation to Bid for the Sewerage Treatment Plant (STP) room with septic vault located at Mandaluyong City Dialysis Center (MCDC), F. Martinez Street (C-3 Road), Barangay Addition Hills, City of Mandaluyong;

WHEREAS, on May 23, 2018, a public bidding was held at the Conference Room, Office of the Mayor, 4/F Executive Building, City Hall Complex, Mandaluyong City, wherein three (3) bidders participated by submitting their abstract of the proposals to the Bids and Awards Committee;

WHEREAS, of the three (3) bidders that participated in the aforesaid public bidding, the firm doing business under the name of Alexa Trading and Construction with business address at #10 Delos Reyes Street, Project 8, Quezon City, has been established to have the Lowest Calculated Responsive Bid in the amount of Two Million Two Hundred Five Thousand One Hundred Fifty Seven Pesos (P2,205,157.00) only;

WHEREAS, the said project was duly conducted in accordance with Procurement laws and rules;

WHEREAS, the Sangguniang Panlungsod has acted based on the documents submitted by the Bids and Awards Committee (BAC) and adhered that the undertaking of the officers involved therein performed an orderly conduct of the bidding;

WHEREAS, the completion of the proposed project will redound to the best interest of the affected community, in particular, and the entire City of Mandaluyong, in general.

NOW, THEREFORE, and upon motion duly seconded, and finding that the offer of Alexa Trading and Construction is the lowest and most advantageous to the City of Mandaluyong, the Sangguniang Panlungsod ng Mandaluyong RESOLVED, as it hereby RESOLVES, to authorize the Honorable Mayor CARMELITA A. ABALOS, to sign the Project Contract with Alexa Trading and Construction for the Sewerage Treatment Plant (STP) room with septic vault located at Mandaluyong City Dialysis Center (MCDC), F. Martinez Street (C-3 Road), Barangay Addition Hills, City of Mandaluyong.
