RESOLUTION NO. 2594, S-2018

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR
CARMELITA A. ABALOS TO SIGN THE MEMORANDUM
OF UNDERSTANDING WITH THE UNILAB
FOUNDATION, INC. REGARDING PROJECT INCLUSION

WHEREAS, the City of Mandaluyong is committed in promoting the realization of the rights of disabled persons to participate fully in the social life and the development of the societies in which they live and the enjoyment of the opportunities available to other citizens;

WHEREAS, guided by the *Magna Carta for Disabled Persons*, the City of Mandaluyong, just like the State, recognizes that that disabled persons are part of Philippine society, and it shall give full support to the improvement of their total well-being and integration into the mainstream of society. Toward this end, it shall adopt policies ensuring the rehabilitation, self-development and self-reliance of disabled persons. It shall develop their skills and potentials to enable them to compete favorably for available opportunities;

WHEREAS, disabled persons have the same rights as other people to take their proper place in society. They should be able to live freely and as independently as possible. Disabled persons' rights must never be perceived as welfare services by the Government;

WHEREAS, the City of Mandaluyong also recognizes the role of the private sector in promoting the welfare of persons with disability (PWDs) and shall encourage partnership in programs that address their needs and concerns;

WHEREAS, Unilab Foundation, Inc. (UFI), a non-profit and non-stock organization has an on-going project entitled "PROJECT INCLUSION" wherein it explores innovative ways to improve the quality of life of PWDs through appropriate, participative and sustainable means;

WHEREAS, toward this end, the City of Mandaluyong agrees to cooperate in UFI's PROJECT INCLUSION. A Memorandum of Understanding (MOU) was drafted for the parties that will govern their complementary duties and responsibilities;


WHEREAS, relative thereto, the City Legal Department reviewed the draft MOU, and the same has been found to be reasonably and properly crafted and in accordance with law.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, to authorize the Honorable Mayor CARMELITA A. ABALOS to sign the Memorandum of Understanding with the UNILAB FOUNDATION, INC. regarding PROJECT INCLUSION.

RESOLVED FURTHER, that copies of this Resolution be furnished to the Honorable Mayor CARMELITA A. ABALOS at the Office of the Mayor, Persons with Disabilities Affairs Division, Treasury Department, and Accounting Department for their immediate information.
