WHEREAS, on August 30, 2018, a public bidding was held at the Conference Room, Office of the Mayor, 4/F Executive Building, City Hall Complex, Mandaluyong City, wherein two (2) bidders participated by submitting their abstract of the proposals to the Bids and Awards Committee;

WHEREAS, of the two (2) bidders that participated in the aforesaid public bidding, the firm doing business under the name of Raffy A. Sia Pest Control Specialist, with business address at No. 8 Pacific Street, Baesa II, Quezon City, has been established to have the Lowest Calculated Responsive Bid in the amount of FOURTEEN MILLION NINE HUNDRED NINETY FIVE THOUSAND FIFTY EIGHT PESOS (P14,995,058.00) only;

WHEREAS, the said project was duly conducted in accordance with the Procurement laws and rules;


WHEREAS, the Sangguniang Panlungsod has acted based on the documents submitted by the Bids and Awards Committee (BAC) and adhered that the undertaking of the Officers involved therein performed an orderly conduct of the bidding;
